WAIVER AND RELEASE

In consideration of being allowed to participate in any athletic/dance event sponsored by, and/or other related events and activities which are in any way associated with, (collectively the "Event") the above locations or their officers, directors, representatives, employees, volunteers, or agents (collectively referred to as the "protected persons"), and intending to be legally bound hereby, the Participant and Participant's parent(s) agree as follows:

1. If the Participant is a minor, the Parent(s) and/or Guardian(s) will instruct the minor participant that prior to participating he or she should inspect the facilities and equipment to be used, and if the Participant believes anything is unsafe, he or she should immediately advise his or her dance/fitness teacher or supervisor of such condition(s) and refuse to participate.
2. Each person acknowledges and fully understands that the Participant will be engaging in activities alone and with others that involve risk of serious injury, including permanent disability and death, and severe social and economic losses. These injuries and losses which might result not only from his or her own actions, inactions or negligence, but the action, inaction or negligence of others or the condition of the above locations or of any equipment used. Further, there may be other risks not known or not reasonably foreseeable at this time.
3. Parent(s) and/or Guardian(s) shall be responsible for any and all damages caused to the above locations, equipment or otherwise by the Participant.
4. Participant and Parent(s) and/or Guardian(s) hereby expressly agree to and shall indemnify, defend and hold harmless Protected Persons, and their respective heirs, administrators, executors, successors and/or assigns, from any and all, including actual, potential and threatened, claims, demands, damages, costs, including attorney's and expert's fees expenses, loss of services, action and causes of actions, and suits at law and in equity, arising out of or relating to the Participant's involvement in the Event.
5. Participant and Parent(s) and/or Guardian(s) hereby forever waive and release Protected Persons, and their respective heirs, administrators, executors, successors and/or assigns, from any and all claims, demands, damages, costs, including attorney's and expert's fees expenses, loss of services, action and causes of actions, suits at law and in equity, which they, and/or their respective heirs, administrators, executors, successors and/or assigns, do, may or might have, arising out of or relating to the Participant's involvement in the Event.
