MINUTES OF REGULAR MEETING HELD MARCH 16, 2004

The Regular Meeting of the Borough of Washington, Warren County, New Jersey was held in the Council Chambers of Borough Hall at 8:00 P.M.

Roll Call: Housel, Van Deursen, Bertoline, Giaimis, McDonald and Doty.

Mayor Van Deursen noted for the record that Councilwoman Glaser's son was in the hospital and there was a chance she would not be in attendance this evening.

The Flag Salute was led by the Mayor.

"The requirements of the 'Open Public Meetings Law" P.L. 1975, Chapter 231 have been satisfied in that adequate notice of this meeting has been published in the Star Gazette and posted on the Bulletin Board of Borough Hall stating the time, place and purpose of the meeting as required by law.

COUNCIL APPEARANCE:

Richard P. Cushing, Esq., Municipal Attorney

Attorney Cushing appeared before the governing body and summarized his duties as Municipal Attorney representing Council. Rather than to go into any lengthy talk he outlined the areas in which he represents the Council such as legal research, preparation of ordinances and resolutions where requested, matters of ethics and litigation, all as required by law. He opened it up to the Council for questions. Mr. Cushing was asked how many years he has served the Borough? Mr. Cushing has been retained as the Borough's attorney since 1986.

Mayor Van Deursen, on behalf of Council, thanked Attorney Cushing for his professional service to the governing body and this community.

MINUTES:

Special Meeting – February 26, 2004 and Regular Meeting – March 2, 2004

Mayor Van Deursen entertained a motion to approve the minutes of the regular meeting of February 26th and March 2, 2004.

Some corrections were noted by Councilwoman Bertoline and Councilman McDonald. A correction on Page 3 of the minutes March 2nd was noted by Councilwoman Bertoline – 30 gallon containers with wheels, Page 4 on the vouchers, it should read North Prospect Street and on Page 8 on Resolution #44-2004. Councilwoman Bertoline's question on whether the trees were planted was answered in the affirmative by Engineer, Robert Miller. Councilman McDonald noted that on Page 13 and Page 17 the vote reflected that the motions were "defeated", not "carried".

It was therefore moved by Giaimis, seconded by McDonald that the minutes of the Special Meeting held February 26, 2004 and March 2, 2004 be approved as corrected.

Mayor Van Deursen entertained remarks from the audience on items that were not on the agenda.

<u>Fire Chief, Joseph Fox, 96 Park Avenue</u> requested the Council to go into Executive Session to discuss a personnel matter.

It was therefore moved by Bertoline, seconded by Giaimis that the Council go into **Executive Session to discuss a personnel matter.**

It was moved by Giaimis, seconded by McDonald that the Council go out of Executive Session back into open session at 8:45 PM.

PRESENTATION:

Board of Education Presentation of 2004-2005 School Budget.

The Manager distributed information on the School Budget for Council's information. Due to school closing as a result of the snow, they were unable to attend this evening's meeting. They have invited the Mayor and Council to a meeting at the Memorial School Library, Tuesday, March 30, 2004 at 7:30 PM.

ORDINANCES:

<u>Ordinance #5-2004</u> - Amending Ordinance #7-2003 – Creating a Special Improvement District (First Reading)

An ordinance amending Ordinance #7-2003 creating a Special Improvement District was introduced by Councilman McDonald.

It was further moved by McDonald, seconded by Bertoline that the Clerk read Ordinance #5-2004 by title only.

Roll Call: Van Deursen, Doty, Bertoline, McDonald, Housel and Giaimis.

Ayes: 6, Nays: 0. Motion carried.

The Clerk read Ordinance #5-2004 entitled, "AN ORDINANCE TO AMEND ORDINANCE #7-2003 CREATING A SPECIAL IMPROVEMENT DISTRICT FOR THE WASHINGTON BOROUGH BUSINESS COMMUNITY".

Council Discussion:

Manager Fisher explained the purpose of this ordinance. This particular property was part OF the Special Improvement District and has been removed as it qualifies as a tax-exempt property. This ordinance is necessary to remove them from S.I.D.

It was moved by Housel, seconded by McDonald that Ordinance #5-2004 be approved on first reading.

Discussion: It was noted that the removal of this property would have some impact on the S.I.D. budget.

It was further moved by McDonald, seconded by Housel that Ordinance #5-2004 be published in the Star Gazette March 25, 2004 and that the public hearing be scheduled for April 6, 2004.

<u>Ordinance #6-2004</u> – Providing for the Implementation of a "Five Year Tax Exemption and Abatement Law" in the Borough (First Reading)

An ordinance providing for the implementation of a "Five Year Tax Exemption and Abatement Law" was introduced by Councilman Housel.

It was further moved by Housel, seconded by Bertoline that the Clerk read Ordinance #6-2004 by title only.

Roll Call; Giaimis, Housel, Van Deursen, Doty, Bertoline and McDonald.

Ayes: 6, Nays: 0. Motion carried.

The Clerk read Ordinance #6-2004 entitled, "AN ORDINANCE PROVIDING FOR THE IMPLEMENTATION IN THE BOROUGH OF WASHINGTON OF THE "FIVE YEAR TAX EXEMPTION AND ABATEMENT LAW" PURSUANT TO N.J.S.A. 40A:21-1, ET SEQ."

Discussion: A new revised fee schedule was presented this evening. Also, Attorney Cushing noted that there were some headings missing from some of the paragraphs which he will correct and provide the Clerk with a new copy.

It was moved by McDonald, seconded by Housel that Ordinance #6-2004 be approved on first reading.

Roll Call: Bertoline, McDonald, Doty, Van Deursen, Housel and Giaimis.

Ayes: 6, Nays: 0. Motion carried.

It was moved by McDonald, seconded by Bertoline that Ordinance #6-2004 be published in the Star Gazette on March 25, 2004 and that the public hearing be scheduled for April 6, 2004.

Roll Call: Giaimis, Housel, Van Deursen, Bertoline, McDonald and Doty.

Ayes: 6, Nays: 0. Motion carried.

REPORTS:

It was moved by Giaimis seconded by McDonald that the Police, Collector-Treasurer's, Road Department O.T., A & E O.T., WWTP and Building Permit reports be accepted as presented and filed.

Discussion: Councilman McDonald had a question on the Collector-Treasurer's report under the revenue section dealing with the stop payment check charges? The Manager did not know the answer to his question so he will check with Mrs. Stasyshan and get back to Councilman McDonald.

Ayes: 6, Nays: 0. Motion carried.

VOUCHERS:

Mayor Van Deursen entertained additions or questions of the vouchers and claims.

Councilwoman Bertoline requested that the Kiwanis dues for the Manager listed on Page 1 of the claims list of 3-16-04 be pulled temporarily from the list for further discussion. The amount is \$ 276.00 for July thru December, 2004.

Councilman McDonald had a question on the handwritten list on Page 13 on the car repair for Public Assistance of which the Manager answered.

Mayor Van Deursen suggested that a poll be taken as to whether the Kiwanis dues should be pulled from the vouchers and claims list. Councilwoman Bertoline is only one person on the governing body.

The Clerk took a poll of Council. There were 2 Nays: Van Deursen, Housel and – 4 Ayes: Bertoline, Giaimis, McDonald and Doty.

Motion carried.

The dues will be withdrawn temporary from this claims list for further consideration.

A motion was made by McDonald, seconded by Housel that the vouchers and claims be approved in the amount of \$555,114.79 and the handwritten vouchers for the month of February in the amount of \$202,887.02 as reflected in the debit/credit memorandum on file in the Collector-Treasurer's office.

Roll Call: Giaimis, Housel, Van Deursen, Doty, Bertoline and McDonald.

OLD BUSINESS:

Discussion - Garbage, Rubbish and Refuse Ordinance

Discussion was held with regard to amending the Garbage and Refuse Ordinance.

The attorney prepared an ordinance based on some discussion held at the last meeting.

The discussion that took place dealt with the size garbage cans that would be acceptable for pick-up. After discussion with the contractor, and some research as to the size containers that would be acceptable, it was agreed that a 32 gallon container instead of a 30 gallon container would be picked up.

Councilwoman Bertoline questioned whether we could consider a 35 gallon container. This size container would not be acceptable with O.S.H.A. Standards.

Councilman Bertoline also questioned Section 47-15 of the Code dealing with outside parties picking up refuse. This section specifically deters scavengers from coming into town going through garbage.

The copy of the ordinance that the Council has is being distributed to residents and has been underlined for those specific sections that better enable them to understand the garbage and refuse guidelines.

Councilman Housel had a question on 47-7B that dealt with pick-up of vegetative waste. His question was answered to his satisfaction.

It was therefore moved by Giaimis, seconded by McDonald that the necessary amendment to the ordinance be prepared amending the size of the container from a 30 gallon to 32 gallon.

Discussion: Councilman Housel suggested that any other amendments to be proposed should be discussed with the contractors before placing the garbage and refuse specifications out for bid.

Roll Call Giaimis, Housel, Van Deursen, Doty, Bertoline and McDonald.

NEW BUSINESS:

Resolution #56-2004 – Adjust Sewer Billings as a Result of Appeals filed

The following Resolution was moved by McDonald, seconded by Bertoline and adopted:

A RESOLUTION TO ADJUST SEWER BILLINGS AS A RESULT OF APPEALS FILED IN ACCORDANCE WITH CHAPTER 70, SECTION 13 OF THE CODE OF THE BOROUGH OF WASHINGTON.

WHEREAS, the Borough of Washington commenced operations of a municipal sewer utility in January of 1999; and

WHEREAS, certain residents and property owners have filed requests for appeal of their sewer service charge with documentation to justify modification of their charges which have been reviewed by the Borough Manager; and

WHEREAS, there is a need to provide expeditious review and approval of those appeals, which are determined to be meritorious without the necessity of a formal hearing in front of the governing body; and

WHEREAS, all parties affected by this resolution will be notified of the action taken, in writing, and notified of an opportunity to appear, in person, at a formal hearing of the governing body, if dissatisfied with the preliminary decisions made herein.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Borough of Washington, in the County of Warren, State of New Jersey that the following appeals are granted on a preliminary basis, subject to the right of the applicant to a formal hearing before the governing body:

RESOLUTION IN SUPPORT OF SENATE BILL S-128 AND ASSEMBLY BILL A-939

WHEREAS, the New Jersey Supreme Court has recently ruled that pubic entities may be liable for punitive damages in certain circumstances; and

WHEREAS, the Borough of Washington believes that the award of punitive damages against public entities is unfair in that it unfairly burdens the taxpayers of the Borough for conduct for which they are not responsible; and

WHEREAS, Senate Bill S-128 and Assembly Bill A-939 address the issue of punitive damages again municipalities in a way that is reasonable and fair.

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Borough of Washington, Warren County, New Jersey, hereby express their support for Senate Bill S-128 and Assembly Bill A-939 and request all members of the Senate and the Assembly vote to support these bills as to protect the taxpayers of all municipalities from the unfair burden of punitive judgments being awarded against them.
