A Regular Meeting of the Borough of Washington, Warren County, New Jersey was held in the second floor Council Chambers of the Borough Municipal Building at 8:00 P.M. on Tuesday, December 21, 2004.

South Lincoln Avenue Parking – Engineer's report

Engineer, Robert Miller submitted a report regarding South Lincoln Avenue to the Manager December 7th at which time a memo was sent with this draft report to the Police Chief, Fire Chief and Emergency Squad for their review of this proposal. To date no recommendations or the review of this proposal has been received from the emergency departments.

The engineer noted that he did not recommend parking on either side of this street. At its widest point the street is only 24' wide.

The Manager was directed to follow up on this with the emergency departments.

To expedite things, the Mayor suggested forming a sub-committee to set a meeting to discuss this issue further. Councilman Alex Buoye and Councilman Terry Housel will serve on this committee with the Engineer and Manager.

WHEREAS, the Treasurer's office was made aware that this check amount was for the wrong invoice. The vendor's invoice for \$171.30 was previously paid. The amount to cover the current invoice should be \$68.10; and

Resolution #229-2004 – Increasing the Bid Threshhold & Appointing a Qualified Purchasing Agent

Prior to introducing a motion to adopt, Manager Sheola explained the purpose and intent of this resolution. This resolution allows Council to increase the bid threshold to \$25,000.00 if a Qualified Purchasing Agent is appointed. Manager Sheola has been certified by the Division of Local Government Services through the Department of Community Affairs as a Qualified Purchase Agent.

It was therefore moved by Housel, seconded by McDonald that the following Resolution be adopted:

RESOLUTION #229-2004

RESOLUTION INCREASING THE BID THRESHOLD AND APPOINTING A QUALIFIED PURCHASING AGENT, PURSUANT TO N.J.S.A. 40a:11-3A AND N.J.A.C. 5:34-5 ET. SEQ.

WHEREAS, the recent changes to the Local Public Contracts Law gave local contracting units the ability to increase their bid threshold up to \$25,000.00; and

WHEREAS, N.J.S.A. 40A:11-3a, permits an increase in the bid threshold if a Qualified Purchasing Agent is appointed as well as granted the authorization to negotiate and award such contracts below the bid threshold; and

WHEREAS, N.J.A.C. 5:43-5 et seq. establishes the criteria for qualifying as a Qualified Purchasing Agent; and

WHEREAS, Richard J. Sheola possesses the designation of Qualified Purchasing Agent as issued by the Director of the Division of Local Government Services in accordance with N.J.A.C. 5:34-5 et seq.; and

WHEREAS, the Borough of Washington desires to take advantage of the increased bid threshold.

NOW, THEREFORE, BE IT RESOLVED, that the governing body of the Borough of Washington, in the County of Warren, in the State of New Jersey hereby increases its bid threshold to \$ 25,000.00; and

BE IT FURTHER RESOLVED, that the governing body hereby appoints **Richard J. Sheola** as **Qualified Purchasing Agent** to exercise the duties of a purchasing agent pursuant to N.J.S.A. 40A:11-2(30), with specific relevance to the authority, responsibility, and accountability of the purchasing activity and contracting unit; and

BE IT FURTHER RESOLVED, that in accordance with N.J.S.A. 5:34-5.2 the Borough Clerk is hereby authorized and directed to forward a certified copy of this Resolution and a copy of **Richard J. Sheola's** certification to the Director of the Division of Local Government Services.

<u>Letter or Resignation as a Council Member – Marianne Van Deursen</u>

A letter of resignation from the Mayor's Council seat was received by the governing body. This resignation is the result of the November election wherein our present Mayor, who was appointed Mayor by the governing body for a two year term which will expire December 31, 2004, ran on the ballot and was successfully elected as Mayor for a four (4) year term beginning January, 2005. There is still two (2) full years left of Mayor Van Deursen's term which shall expire December, 2006.

The letter was acknowledged and received by the governing body and the Clerk was directed to notify the Chairman of both the local Republican Committee and the County Committee, as well as the County Clerk and County Election Board.

COUNCIL REMARKS:

Mayor Van Deursen reminded Council members of the Holiday Lighting Contest. She requested that Council let her know their choice as soon as possible so that the plaque can be ordered by Fliegaufs.

She wanted to thank Councilman Giaimis, Councilman McDonald and Councilwoman Bertoline for their contribution serving on the governing body and commended them for the fine job they did. She wished them all the best in their future endeavors and stated that it had been a pleasure working with them through the good and the bad.

Mayor Van Deursen requested that an agenda item be placed on the next agenda to appoint a Committee or Volunteer Board to work on the plan to provide senior services to the senior citizens of our community.

Mayor Van Deursen recognized Chief Joseph Fox in the audience. Chief Fox had been on a fire call and was now available to give his yearly report to the governing body.

A copy of his report was distributed to the Council for their information. He brought them up-to-date with their membership which they currently have 47 active members and 8 junior members. He briefed the Council on their training this past year. To date they have answered 167 calls for a total of 1631 man hours.

He outlined the condition of their fire apparatus which is beginning to show signs of age and the problems they are experiencing. They are requesting that Council start looking into replacing the 1978 Mack pumper and the 1975 Aerialscope due to the amount of mechanical issues and age of the apparatus he touched upon in his report.

They also planning some new fire training classes and will concentrate on continuing to develop their Junior Firefighter program.

Mayor Van Deursen thanked the Chief for his very comprehensive report and on behalf of the governing body thanked him and his department for the fine job they do for the community. Council Minutes – 12-21-04 (Cont'd.) Page 7
