Monthly Report
For the Month of April, 2010

Traffic

This past month, we had 2 new DWI summons, 85 moving violations, and 22 parking summonses issued for a total of 109 traffic summonses newly filed with this court and entered into ATS. This court has disposed of 3 DWIs, 106 moving and 101 parking summonses. At the end of the month, we have 4 DWIs, 118 moving and 123 parking summonses pending.

Criminal

We have added 9 new indictable charges, 24 DP and PDP charges and 32 Borough Ordinances into the ACS system. We have disposed of 17 DP and PDP charges and 54 Borough Ordinances which leaves 142 pending DP & PDP charges and 141 Borough Ordinances. We have collected \$26,981.00 this month of which the Borough received \$16,389.48. In addition to the daily functions, we have collected \$1,014.00 cash bail and disbursed \$1,617.00 cash bail.

We had 8 callouts this past month to issue new warrants and/or to commit defendants to the county jail. Failure to appear notices and delinquent time payment notices are mailed out weekly. We have issued warrants and have suspended the driving privileges of defendants who have failed to appear, who are seriously delinquent in their time payments or for non-compliance of court orders.

Other

There were 3 new cases referred to Community Dispute Resolution Program this month.
