

### BOROUGH OF WASHINGTON BOARD OF HEALTH REPORT December 12, 2016

#### **COMPLAINTS**

The following complaints were investigated:

- <u>42 Carlton Avenue</u> —Overgrown grass and weeds at the abandoned property. A reinspection was conducted. The weeds had died due to the cold weather. A reinspection is scheduled for June.
- <u>90 East Church Street</u> Poison ivy in the hedges, leaky roof, mold and rodents. (The building is unoccupied.) A reinspection was conducted. There are no issues at this time. The complainant was advised to call in the spring if the nuisance reoccurs. File closed.
- <u>Krauser's, East Washington Avenue</u> Mouse droppings throughout the store. A reinspection is scheduled.
- <u>39 West Washington Avenue</u> Bedbugs. It was reported that the apartment was scheduled to be cleaned out and exterminated. Attempt to arrange to inspect have been unsuccessful.
- <u>8 & 9 Adams Street</u> Rats due to deer parts. A reinspection was conducted. No deer parts or evidence of rats were observed. File closed.
- <u>7 Railroad Avenue</u> Bedbug issue. The complainant reported that the apartments are scheduled to be exterminated.
- <u>5 & 9 Heather Hill</u> Tall grass, snakes, and garbage on the empty lots. A violation notice was issued. The responsible party requested additional time to abate the nuisance. A reinspection is scheduled.
- <u>7 Railroad Avenue</u> A complaint was received concerning no heat and garbage. The DCA was notified of the new complaint. An inspection was attempted, but no one was home. The dumpster was overflowing. A violation notice was issued. A reinspection is scheduled.

Hometown Fried Chicken, 25 East Washington Avenue - A complaint was received concerning garbage dumped in the parking lot that may be attracting mice. An inspection was conducted. Cardboard, full bags of garbage and food debris was observed in the alley. The restaurant owner was aware of the situation and reported that a solution is being sought, as a dumpster cannot go in the alley due to its steepness. A reinspection was conducted. No change was noted. It was reported that a dumpster was being allowed if it is put on a platform. It was felt that this would be completed within a few days, and the garbage is being removed daily in the meantime. A violation notice was issued.

<u>65 Grand Avenue</u> - A complaint was received concerning bedbugs and mold from leaks. This complaint is currently under investigation.
