#### **OLD BUSINESS:**

Permitted Business Uses:

Council had made a specific request. Do not want tattoo parlors in B2 district. Chair noted that the town needs appropriate places for certain businesses. Mayor McDonald asked about piercing businesses. Attorney Ours stated that the description covers it "tattoo or piercing parlors". Tina Truman stated that a variance can be sought if the business is not a permitted use. Attorney Ours noted that the use variance would go to the zoning board.

Under pawn shops, etc., Mayor McDonald wants to make sure that mortgage brokers were not being omitted. Chair VanDeursen stated that the wording in this section would be for check cashing businesses. Dan Aaron commented that the Borough needs businesses that will make people stop in town. Attorney Ours noted that in the section under permitted uses "finances & insurance" is listed.

Adam Fitting asked about convenience stores being prohibited. Do not want too many in one area.
