William Phillips came forward to address the Board. He is buying the Henkels & McCoy property and wants to merge 2 parcels and then subdivide for residential use. Mr. Phillips handed out tax map copies to the Board. The surrounding area is already residential. He will contact Jesse at Biggs Engineering when he decides to proceed.

Ray Rice, Jade Partners, LLC, came forward to address the Board. He presented an informal review of a plan he will submit in the near future for the old PNC/St Cloud site. Attorney Gruenberg noted that this is not a public hearing, just an introduction to the plan.

Frank Molette, licensed architect/planner, presented the proposed plan. The 1st level will be retail and levels 2-4 will have 48 residential units with half of the units 1bedroom and the other half 2 bedroom units. They will comply with residential codes, zoning and the redevelopment plan.

Dan Aron asked if it was a wise step based on the vacancies at Midtown. Ray stated that he has interest for 70% of the retail space. This project will target more upscale residents. Rich Pellizoni, engineer, stated with they will maintain the entrance by PNC as a one-way ingress. Total of 3 ingresses and 2 egresses.

Marianne inquired about the old Krauszers. Ray stated that it is not part of this plan. Have a contract with Krauszers and is also in talks with the Borough regarding the parking lot behind Krauszers. The proposed project will not have low income rentals because of the cost.

Mayor McDonald stated that Ray had presented the project to Council. Next Council meeting is on 5/21/13 and members should attend to support the project. Attorney Gruenberg cautioned about Board members supporting the project before application comes before the Board.
