- 1. 17 Lambert St. Soil Test Results J. Brown will try a different contact at Rutgers to get a better understanding of the soil test results. The report was inconclusive to determine if the owners could replace their dead trees yet.
- 2. Pocket Park Tree Replacement K. Halpin will submit the cost of a replacement tree for the police report.
- 3. Pine Tree on Borough Property K. Halpin will contact DPW Supervisor, Jonathan James to see if the dead Pine can be removed. It is located on the Southwest side of the Washington Borough Emergency Squad building.
- 4. Remaining 2020 Shade Tree Commission Budget A Motion was made by G. Pohorely and seconded by D. Butler to purchase tree diapers with the remaining funds in the 2020 budget. K. Halpin researched the product and the Commission agreed that it would be a beneficial investment.
