OLD BUSINESS:

- 1. 2021 NJUCF Stewardship Grant The Shade Tree Commission received Conditional Approval for the NJUCF Stewardship Grant. Conditional Approval requires further discussion with the NJUCF to clarify aspects of the Commission's project and determine the amount of the grant award. This grant will provide the funding for a new inventory.
- 2. CEU's Update J. Brown and M. Christie are registered to participate in the upcoming CORE training sessions. The online course opens on September 10th. This is a beneficial experience, especially for new Commissioners.
- 3. NJ Shade Tree Federation Conference- K. Halpin and G. Pohorely will be attending the Oct. 22nd sessions. This will provide the necessary 8 CEU's that are required annually for approved status purposes. The preregistration fees are \$125.00 per person this year. S. Marr will be attending the League of Municipalities conferences in November for the Green Team and the Shade Tree Commission.

The town ordinance currently states that the property owner is responsible for any sidewalk repairs. Pohorely will update their information at the November Shade Tree meeting.
